INFORMATION ITEM: UofL Foundation - Keith Sherman

Mr. Sherman, the Executive Director and Chief Operating Officer of the UofL Foundation gave a brief overview of what the Foundation does and how it has grown since he came to UofL in late 2016. The Foundation is a non-profit entity, separate from the university and was created to receive, invest and steward donor gifts made to support the academic mission of the university. There are two types of gifts made to the Foundation – expendable gifts and endowments. Expendable gifts are not invested and can

be used until the funds are gone. An endowment is invested to grow and to last for years. Upon his arrival in 2016, many endowment accounts were under water (worth less than their purchase price) due to overspending. As of March 2024, all endowment accounts are healthy and no longer underwater. This report is online and linked above.

INFORMATION ITEM: Center for Military-Connected Students - Dakota Walker

Mr. Walker presented to the Staff Senate about the Center for Military-Connected Students and services that the Center provides. A military-connected student includes veterans, active duty, dependents, reserve, national guard and ROTC students. The Center supports these UofL students from all over the world, and has garnered a well-respected reputation. This presentation is linked above.

INFORMATION ITEM: Free Speech - Michael Mardis/David Parrott

Dean Mardis and Dr. Parrott updated the Staff Senate on the many details regarding free speech on campus. The best source of information is the university's <u>free speech web site</u>. This was developed after the state passed KRS-1 64348, which is the state law on speech on university campuses. Because UofL is a state institution, it must abide by all federal and state laws allowing free speech, no matter how contentious or unpopular it may be.
