#### ACTION ITEM: Officer Elections - Stephanie Kittle/Kristin Roberts

Senator Stephanie Kittle and Senator Kristin Roberts led the Senate through the officer election process. After each candidate spoke, questions from the floor were taken. The online ballot remained open until 3:30 p.m..

#### **INFORMATION ITEM: UofL Foundation - Keith Sherman**

Mr. Keith Sherman gave an overview of the Foundation investment philosophy and strategy. The Foundation has an endowment pool that makes funds available to the University each year on July 1<sup>st</sup>. As of this meeting, the endowment pool is at its all-time high at \$917M. When Mr. Sherman arrived at UofL in 2016, the pool was \$565M. That growth was achieved through donations, reduced spending, and a change in investment strategies. A pool this large takes expertise to manage and must follow the Kentucky Uniform Prudent Management of Institutional Funds Act, a Kentucky state statute. This ensures that institutions invest in solid sound vehicles that will give positive returns in most years. These will not see the highest highs or the lowest lows in returns. For UofL's portfolio, we look for blue chip established funds, some hedge funds, bonds and more. Because of the size and expertise needed to handle the endowment the fund management was outsourced to the Boston-based firm Prime Buchholz. LLC.

#### **INFORMATION ITEM: Retirement Update - Greg Paradiso**

Mr. Greg Paradiso, from Benefits in Human Resources spoke about a change to the participant fee for retirement plans. In 2022, the Retirement Oversight Committee was established to work solely on behalf of the participants and make improvements to the retirement plan. Retirement plan participants are charged a service fee for the plan's expenses. The fee structure had not been updated over the years and, depending on the investments, there was a lot of disparity in fees. This is not how most institutions in higher education operate. Working with a consultant, the Retirement Oversight Committee did an analysis and moved towards the best practice of fee leveling. This way each retirement plan participant will pay the same fee for the same plan. A notification, sent several months ago, announced this would be put in place July 1.
